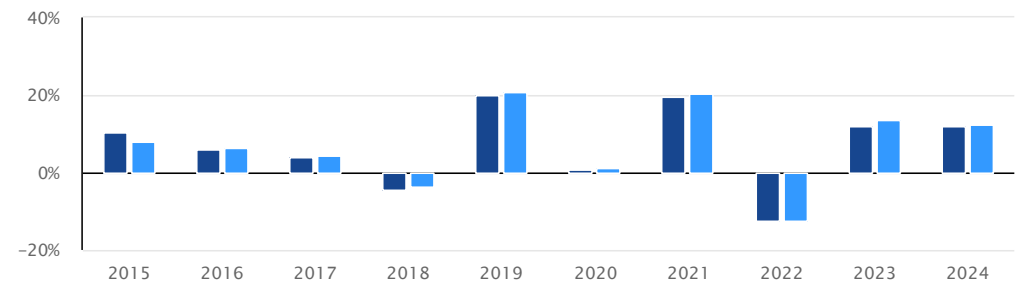
Fund Description
