## Manager's Report

### MARKET REPORT

#### Gold Miners

This market background summary covers VanEck Vectors™ Gold Miners UCITS ETF and VanEck Vectors™ Junior Gold Miners UCITS ETF.

- For the period from 1 January 2021 to 30 June 2021, VanEck Vectors™ Gold Miners UCITS ETF and VanEck Vectors™ Junior Gold Miners UCITS ETF returned (-5.77%) and (-14.11%) respectively.
- Gold stocks are also down for the first part of the year, reflecting gold's performance. June was a terrible month for the gold equities, erasing all the gains made in the first five months of 2021. However, the larger cap gold stocks, as measured by the NYSE Arca Gold Miners Index (GDMNTR) are still outperforming gold year to date, with the GDMNTR down 5.62% during the first half. This is atypical in a period of declining gold prices, and may be a reflection of several factors.
- Being that May was basically the first month in 2021 that excessive inflation was actually reported in primary economic indicators, we believe that gold responded relatively nicely with an overall US\$137.74 (7.6%) gain to end the month at US\$1,906.87 per ounce.

Gold's response to changes in U.S. Treasury yields persisted through April, as prices trended to a monthly high of US\$1,798 per ounce on the 22nd while, at the same time, 10-Year yields fell to a monthly low of 1.53%. To end the month, yields reversed course from their lows and gold eased to US\$1,770.55, eventually ending April with a gain of US\$63.55 (3.6%).

- Gold spent March consolidating around the US\$1,700 per ounce level, falling to US\$1,676 on March 8 before recovering to US\$1,707 by March 31 and ending the month down US\$26.33 per ounce (-1.5%) from its February close. Gold experienced a significant decline early in the month following a strong move higher in long-term Treasury rates after Federal Reserve (Fed) Chairman Jerome Powell promised to keep monetary policies steady in a Wall Street Journal interview.
- Gold reached its low for the month on February 26 at US\$1,717 per ounce and finished at US\$1,734.04 per ounce for a US\$113.61 (6.2%) loss.
- Gold had a strong start to the year, moving to its monthly high of US\$1,959 per ounce on January 6 at the same time the U.S. dollar index (DXY)<sup>1</sup> made fresh three-year lows. However, gold quickly reversed course as it became clear the US democrats had won a runoff election in Georgia, which, with the help of a democratic vice president, gave them control of the Senate.

#### Morningstar US Wide Moat

This market background summary covers VanEck Vectors Morningstar US Wide Moat UCITS ETF.

- For the period from 1 January 2021 to 30 June 2021, VanEck Vectors Morningstar US Wide Moat UCITS ETF returned 19.28%.
- VanEck Vectors Morningstar Wide Moat UCITS ETF seeks to replicate as closely as possible, before fees and expenses, the price and yield performance of the Morningstar® Wide Moat Focus Index™ (MWMFTR). The index targets U.S. companies with sustainable competitive advantages, i.e., "moats," and attractive valuations in the view of Morningstar's team of more than 100 equity analysts.
- According to the forward-looking process of Morningstar's Equity Research group, companies with moats have the potential to create above-average returns for longer periods of time. The index's approach to investing in U.S. companies with wide economic moats when they are attractively priced has resulted in long-term outperformance versus the broad U.S. equity market.
- The Morningstar Wide Moat Focus Index (the "Moat Index" or "Index") underperformed the S&P 500® Index in June (1.15% vs. 2.33%, respectively). Despite the modest underperformance, the Index remains ahead of the S&P 500 Index by over 4.5% through this year's halfway point (19.77% vs. 15.25%, respectively).

#### Morningstar US Wide Moat (continued)

- In a reversal of the value rotation of 2020, the Moat Index saw its exposure to financials decrease and tech stocks increase as valuation opportunities began presenting themselves in some areas of the market where there hasn't been much value to be had in recent years. Growth exposure increased and value decreased leaving growth, value and core style exposure nearly evenly distributed within the Index.

#### Morningstar Global Wide Moat

This market background summary covers VanEck Vectors Morningstar Global Wide Moat UCITS ETF.

- For the period from 1 January 2021 to 30 June 2021, VanEck Vectors Morningstar Global Wide Moat UCITS ETF returned 12.44%.
- VanEck Vectors Morningstar Global Wide Moat UCITS ETF provides exposure to global with Morningstar Economic Moat Ratings of wide that are trading at the lowest current market price/fair value ratios.

#### Emerging Markets Government Debt

This market background summary covers VanEck Vectors™ J.P. Morgan EM Local Currency Bond UCITS ETF.

- For the period from 1 January 2021 to 30 June 2021, VanEck Vectors™ J.P. Morgan EM Local Currency Bond UCITS ETF returned (-3.56%).
- Within emerging markets debt, local currency bonds have historically provided the greatest diversification benefit compared to U.S. dollar-denominated emerging markets sovereign or corporate bonds, as measured by the segment's relatively low correlation to other asset classes.
- The ongoing powerful underlying trends supporting EM include global growth broadening out first from China, now from the U.S. and soon from Europe and the rest of the world. This is happening to an emerging markets universe that has more than met the Fed's expected interest rate hikes and is seeing improved fiscal outlooks (revenues are rising faster than expected). On top of that, EM countries have extremely resilient external accounts, which have been the primary or only cause of serious setbacks in decades past. And, as referred to above, many EM central banks have already started rate-hiking cycles.

#### Emerging Markets Corporate Debt

This market background summary covers VanEck Vectors™ Emerging Markets High Yield Bond UCITS ETF.

- For the period from 1 January 2021 to 30 June 2021, VanEck Vectors™ Emerging Markets High Yield Bond UCITS ETF returned 1.53%.
- Emerging markets corporate high yield bond spreads continue to stand out following the selloff experienced in March and April. Despite the significant rally in spreads thereafter, emerging markets high yield remains attractive from a historical perspective.
- The pace of vaccinations can be a major tailwind for emerging markets but things keep improving – the administered vaccines/population ratio in EM is nearing 50%. We suspect that the upward growth revisions in LATAM and EMEA are already reflecting this positive trend. Still, regional gaps persist. The slow pace of vaccinations in parts of Asia is an obvious risk, and it is weighing on the near-term growth prospects in Malaysia, Thailand, and the Philippines. Another consideration that might gain in importance in the coming weeks is what kind of vaccines EMs are using. The headline vaccination rate might matter significantly less if some vaccines are more effective against the virus's mutations than the others.

#### Fallen Angels

This market background summary covers VanEck Vectors™ Global Fallen Angel High Yield Bond UCITS ETF.

- For the period from 1 January 2021 to 30 June 2021, VanEck Vectors™ Global Fallen Angel High Yield Bond UCITS ETF returned 2.38%.
- Fallen angel bonds are part of the overall high yield universe but unique in that they were originally issued with investment grade ratings and later downgraded to non-investment grade, or high yield. This results in differentiating characteristics versus the broader high yield bond market such as, a higher average credit quality and the crossover from investment grade to high yield markets is where the value proposition of fallen angels originates.
- By this summer, Moody's Investors Service sees the rate of rising stars surging to 11.3% for the 12 months ending July 2021, up from 3.4% a year prior, when looking at the share of U.S. corporate bonds poised to see a ratings boosts to investment grade from the highest Ba1 "junk" category.
- "This forecast, if realized, will be in line with the patterns after both the 2001 and 2008 recessions, when the comparable rate climbed to roughly 10% a year after the post-recession troughs of 4.3% and 6.3%, respectively," the Moody's team wrote in a note this week.

#### Esports and Video Gaming

This market background summary covers VanEck Vectors™ Video Gaming and eSports UCITS ETF.

- For the period from 1 January 2021 to 30 June 2021, VanEck Vectors™ Video Gaming and eSports UCITS ETF returned 3.89%.
- Mobile gaming continues to dominate industry revenues and provide the most growth by segment (compared to PC and console). High demand for next-gen console sales into 2021 should provide an overall favorable backdrop for the video game industry.
- M&A activity from tech conglomerates may continue as these companies look to position themselves favorably in the gaming landscape. They have been purchasing development studios and esports-related businesses to boost their offerings.
- We currently see "return to normalcy" risks and valuation risks for video game companies, but we believe supportive long-term trends are still in place around consumer demand for interactive digital entertainment, cord-cutting and demographics.

#### Semiconductor

This market background summary covers VanEck Vectors™ Semiconductor UCITS ETF.

- For the period from 1 January 2021 to 30 June 2021, VanEck Vectors™ Semiconductor UCITS ETF returned 21.48%.
- Despite the global pandemic and resulting economic downturn, the semiconductor industry remained resilient, finishing 2020 with revenue growth of 6.5%. The semiconductor industry will continue to grow due to the mainstream adoption of IoT, 5G and the increasing semiconductor needs of the automotive sector, according to the 2021 Global Semiconductor Industry Outlook from KPMG and the Global Semiconductor Alliance.

#### Semiconductor (continued)

- “The pervasiveness of technology continues to accelerate across all industries, sectors, and within society at large, arising from the profound shift to home-based work, education, and entertainment,” said Lincoln Clark, partner in charge of KPMG’s Global Semiconductor practice. “This is driving a surge in demand for chip-based products, and semiconductor companies have been quick to react, recover, and realign their businesses to new market needs.”

#### Hydrogen Economy

This market background summary covers VanEck Vectors™ Hydrogen Economy UCITS ETF.

- For the period from 29 March 2021 to 30 June 2021, VanEck Vectors™ Hydrogen Economy UCITS ETF returned 1.25%.
- Hydrogen is the simplest energy dense element that if burned for fuel only, produces water as its byproduct. A fuel cell combines hydrogen and oxygen to produce energy. The challenge has been in producing hydrogen fuel cells at a scale. Falling costs of production along with government and corporate interest alike is supportive of this nascent technology.

#### Digital Assets Equity

This market background summary covers VanEck Vectors™ Digital Assets Equity UCITS ETF.

- For the period from 30 April 2021 to 30 June 2021, VanEck Vectors™ Digital Assets Equity UCITS ETF returned (-14.98%).
- Digital transformation companies engage in a wide variety of business lines within the broader ecosystem such as: payment gateways, hardware, crypto miners, exchanges, crypto holding and trading, software and value added services, banking and asset management.
- Despite the recent negative performances of crypto assets, digital assets usage and implementation including cryptocurrencies and decentralized applications are projected to grow as global adoption continues according to our studies.

#### Tracking Error

The realised tracking error is the annualised standard deviation of the difference in daily returns between a sub-fund and its index. Tracking error shows the consistency of the returns relative to the index over the defined period of time.

Anticipated tracking error is based on the annualised standard deviation of the difference in daily returns between a sub-fund and its index under normal market conditions.

Cash management, efficient portfolio management techniques including securities lending, transaction costs from rebalancing and currency hedging can have an impact on tracking error as well as the return differential between the cash component of the fund. Importantly, these impacts can be either positive or negative depending on the underlying circumstances.

In addition to the above, the sub-funds may also have a tracking error due to withholding tax charged to the sub-funds on any income received from its investments. The level of tracking error arising due to withholding taxes depends on various factors such as any reclaims filed by the sub-funds with various tax authorities, any benefits obtained by the Funds under a tax treaty or any securities lending activities carried out by the Funds.

The table below shows the anticipated annual tracking error of the sub-funds against the realised tracking error of the sub-funds. Realised tracking error is an annualized figure calculated using data from the preceding 12 months observation period.

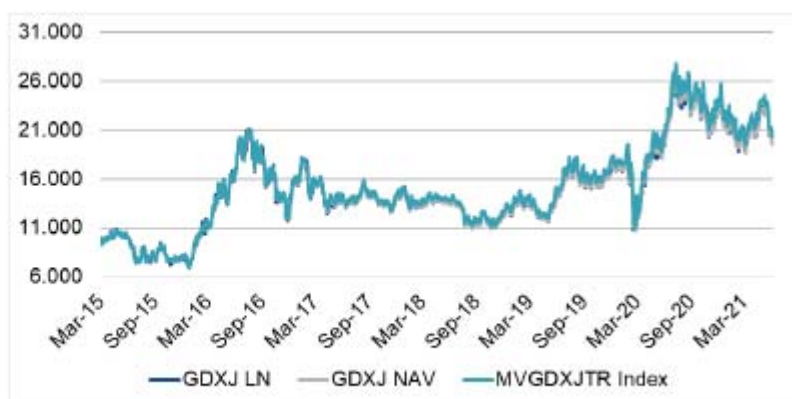

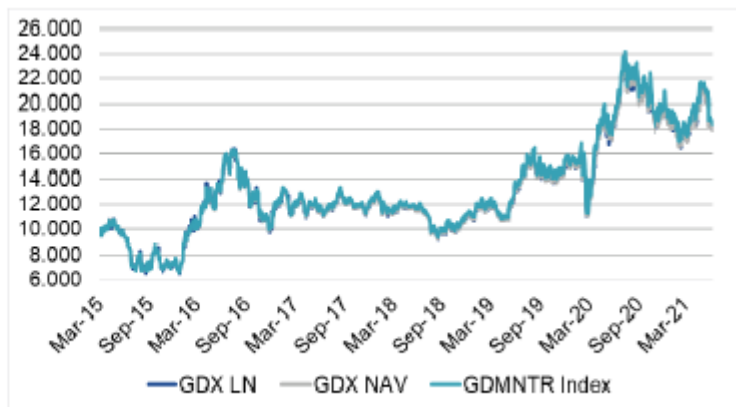

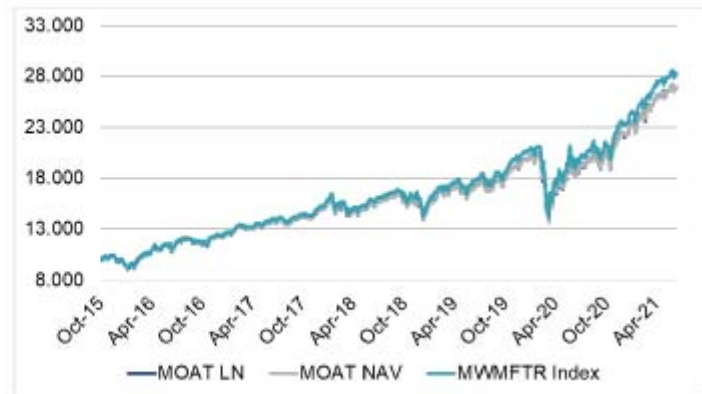

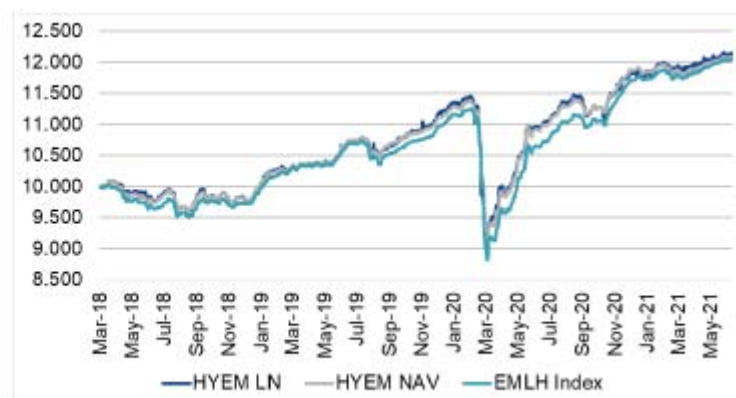

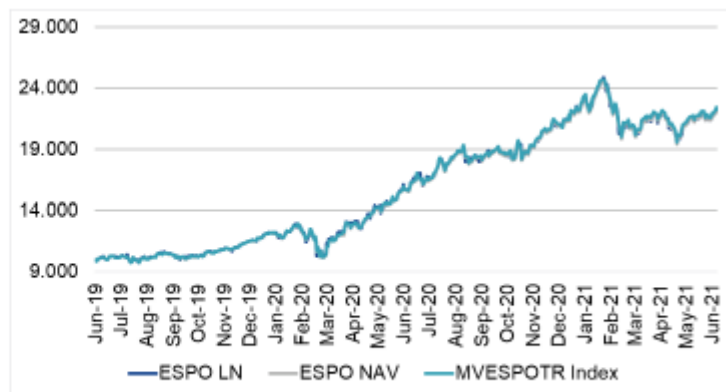

## Notes to the Financial Statements

### 1. Organisation

VanEck Vectors™ UCITS ETFs plc (the “Company”) was incorporated on 26 August 2014 under the laws of Ireland. The Company is a public limited company with variable capital and is structured as an umbrella fund with segregated liability between sub-funds established pursuant to the Companies Act 2014. The sole objective for which the Company is established is the collective investment in transferable securities and/or other liquid financial assets as pursuant to the UCITS Regulations and Central Bank UCITS Regulations. The Company was authorised by the Central Bank of Ireland on 8 December 2014.

As at 30 June 2021, the Company consisted of twelve active sub-funds, collectively the “sub-funds”, and individually the “sub-fund”. As at 30 June 2021, each sub-fund had one share class in issue – USD A Share class.

#### **VanEck Vectors™ Junior Gold Miners UCITS ETF (the “sub-fund”)**

The investment objective of the sub-fund is to track, before fees and expenses, the price and yield performance of the MVIS Global Junior Gold Miners Index (the “Index”).

#### **VanEck Vectors™ Gold Miners UCITS ETF (the “sub-fund”)**

The investment objective of the sub-fund is to track, before fees and expenses, the price and yield performance of the NYSE Arca Gold Miners Index (the “Index”).

#### **VanEck Vectors Morningstar US Wide Moat UCITS ETF (the “sub-fund”)**

The investment objective of the sub-fund is to track, before fees and expenses, the price and yield performance of the Morningstar® Wide Moat Focus Index<sup>SM</sup> (the “Index”).

#### **VanEck Vectors Morningstar Global Wide Moat UCITS ETF (the “sub-fund”)**

The investment objective of the sub-fund is to track, before fees and expenses, the price and yield performance of the Morningstar® Wide Moat Focus Index<sup>SM</sup> (the “Index”).

#### **VanEck Vectors™ J.P. Morgan EM Local Currency Bond UCITS ETF (the “sub-fund”)**

The investment objective of the sub-fund is to replicate, before fees and expenses, the price and yield performance of the J.P. Morgan GBI–EM Global Core Index (the “Index”).

#### **VanEck Vectors™ Global Fallen Angel High Yield Bond UCITS ETF (the “sub-fund”)**

The investment objective of the sub-fund is to replicate, before fees and expenses, the price and yield performance of the ICE Global Fallen Angel High Yield 10% Constrained Index (the “Index”).

#### **VanEck Vectors™ Emerging Markets High Yield Bond UCITS ETF (the “sub-fund”)**

The investment objective of the sub-fund is to replicate, before fees and expenses, the price and yield performance of the ICE Diversified High Yield US Emerging Markets Corporate Plus Index (the “Index”).

#### **VanEck Vectors™ Global Mining UCITS ETF (the “sub-fund”)**

The investment objective of the sub-fund is to replicate, before fees and expenses, the price and yield performance of the EMIX Global Mining Constrained Weights Index (the “Index”).

#### **VanEck Vectors™ Video Gaming and eSports UCITS ETF (the “sub-fund”)**

The investment objective of the sub-fund is to replicate as closely as possible, before fees and expenses, the price and yield performance of the MVIS® Global Video Gaming & eSports Index (the “Index”).

#### **VanEck Vectors™ Semiconductor UCITS ETF (the “sub-fund”)**

The investment objective of the sub-fund is to replicate, before fees and expenses, the price and yield performance of the MVIS® US Listed Semiconductor 10% Capped Index (the “Index”).

#### **VanEck Vectors™ Hydrogen Economy UCITS ETF (the “sub-fund”)**

The investment objective of the sub-fund is to replicate, before fees and expenses, the price and yield performance of the MVIS® Global Hydrogen Economy Index (the “Index”).

#### **VanEck Vectors™ Digital Assets Equity UCITS ETF (the “sub-fund”)**

The investment objective of the sub-fund is to replicate, before fees and expenses, the price and yield performance of the MVIS Global Digital Assets Equity Index (the “Index”).

As at 30 June 2021, the sub-funds of VanEck Vectors UCITS ETFs plc are listed on Euronext Dublin, London Stock Exchange, Borsa Italiana, XETRA and Six Swiss Exchange.

### 2. Basis of Preparation

These condensed interim unaudited financial statements have been prepared on a going concern basis which assumes that the Company will continue in operational existence for the foreseeable future. These condensed interim unaudited financial statements have been prepared under the historical cost convention, as modified by the revaluation of financial assets and financial liabilities at fair value through profit or loss.

The preparation of these condensed interim unaudited financial statements in conformity with International Financial Reporting Standards (“IFRS”) requires the use of estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Although these estimates are based on management’s best knowledge of the amount, event or actions, actual results ultimately may differ from those estimates.

The Board of Directors make estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. There are no estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities.

#### **New standards, amendments and interpretations issued and effective for the financial period beginning 1 January 2021**

There are no standards, interpretations or amendments to existing standards that are effective for the first time for the financial year beginning on 1 January 2021 that might have a material impact on the Company’s financial statements.

#### **New standards, amendments and interpretations issued but not effective for the financial period beginning 1 January 2021 and not early adopted**

A number of new standards and amendments to standards are effective for annual periods beginning after 1 January and earlier application is permitted, however, the Company has not early adopted the new or amended standards in preparing these financial statements.

The following new and amended standards and interpretations are not expected to have a significant impact on the Company’s financial statements:

- COVID-19 Related Rent Concessions (Amendment to IFRS 16)
- Onerous Contracts - Cost of Fulfilling a Contract (Amendments to IAS 37)

### 3. Significant Accounting Policies

These condensed interim unaudited financial statements have been prepared in accordance with IAS 34, “Interim Financial Reporting”, and Irish Statute comprising the Companies Act 2014, the UCITS Regulations and the Central Bank UCITS Regulations. These condensed interim unaudited financial statements should be read in conjunction with the annual audited financial statements for the financial year ended 31 December 2020.

**4. Share Capital**

The Authorised Share Capital of the Company is 2 subscriber shares of €1 each and 1,000,000,000,000 participating shares of no par value. There are no rights of pre-emption attached to the shares.

The company complies with the minimum investment limits by ensuring that investors must generally acquire a minimum of 50,000 shares.

Shareholders are entitled to attend and vote at general meetings of the Company. Every shareholder, holding shares that are present in person or by proxy shall have one vote and on a poll, every shareholder present in person or by proxy shall have one vote for every share of which they are the holder.

The Directors are authorised to allot relevant securities up to an amount equal to the authorised share capital of the Company. No shares were allotted during the financial period ended 30 June 2021 and the financial year ended 31 December 2020.

The Directors reserve the right to reject, in whole or in part, any application for shares. In particular, if the Directors determine that it would be detrimental to the existing shareholders to accept a cash application for shares of any subfund which represents more than 10% of the Net Asset Value of such sub-fund, the Directors may decide that all or part of the application for shares in excess of 10% be deferred until the next Dealing Day. If the Directors decide to defer all or part of the application in excess of 10% the applicant shall be informed prior to the deferral taking place.

### 5. Cash and Cash Equivalents

A financial instrument is regarded as quoted in an active market if the quoted prices are readily and regularly available from an exchange, dealer, broker, industry group, pricing service, or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.

The fair value of financial assets and financial liabilities that are not traded in an active market is determined by using valuation techniques. The Company uses a variety of methods and makes assumptions that are based on market conditions existing at the reporting date. The fair value hierarchy has the following levels:

- Quoted prices (unadjusted) in active markets for identical assets or liabilities (Level 1).
- Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly (that is, as prices) or indirectly (that is, derived from prices) (Level 2).
- Inputs for the asset or liability that are not based on observable market data (that is, unobservable inputs) (Level 3).

As the fair values of the investments for VanEck Vectors™ Junior Gold Miners UCITS ETF, VanEck Vectors™ Gold Miners UCITS ETF, VanEck Vectors Morningstar Global Wide Moat UCITS ETF, VanEck Vectors Morningstar US Wide Moat UCITS ETF, VanEck Vectors™ Global Mining UCITS ETF, VanEck Vectors™ Video Gaming and eSports UCITS ETF, VanEck Vectors™ Semiconductor UCITS ETF, VanEck Vectors™ Hydrogen Economy UCITS ETF and VanEck Vectors™ Digital Assets Equity UCITS ETF are based on quoted prices in active markets, the sub-funds' financial assets measured at fair value are considered Level 1 for the financial period ended 30 June 2021 and financial year ended 31 December 2020.

As the fair values of the investments for VanEck Vectors™ J.P. Morgan EM Local Currency Bond UCITS ETF, VanEck Vectors™ Global Fallen Angels High Yield Bond UCITS ETF and VanEck Vectors™ Emerging Markets High Yield Bond UCITS ETF are based on inputs other than quoted prices, the sub-funds' financial assets are considered Level 2 for the financial period ended 30 June 2021 and financial year ended 31 December 2020.

The Company's assets and liabilities (by class) not measured at fair value at financial period ended 30 June 2021 or financial year ended 31 December 2020 but for which fair value is disclosed within the fair value hierarchy are considered Level 2, except for cash and cash equivalents, which are considered Level 1.

### 7. Efficient Portfolio Management

The Company may, on behalf of each sub-fund and subject to the conditions and within the limits laid down by the Central Bank of Ireland, employ techniques and instruments relating to transferable securities for efficient portfolio management purposes. Transactions for the purposes of efficient portfolio management may be undertaken with a view to achieving a reduction in risk, a reduction in costs or an increase in capital or income returns to a sub-fund and may not be speculative in nature.

The sub-funds may invest in financial derivative instruments ("FDI") for efficient portfolio management or hedging purposes. The sub-funds may use futures, swaps and currency forwards for the purpose of reducing risk associated with currency exposures within the sub-fund. These techniques and instruments may include investments into hedging transactions on currencies to protect against a decline in the value of investments denominated in currencies other than US\$, and against any increase in the cost of investments denominated in currencies other than US\$. The sub-funds employ the commitment approach to assess the global exposure and to ensure that the sub-fund's use of derivative instruments is in accordance with the requirements of the Central Bank of Ireland.

Forward foreign currency contracts can be used to hedge out unwanted currency exposures and to limit the sub-funds exposure to anticipated changes in exchange rates. There are no forward foreign currency contracts held at the financial period ended 30 June 2021 and the financial year ended 31 December 2020.

**7. Efficient Portfolio Management (continued)**

The sub-funds may enter into stock lending, repurchase and/or reverse repurchase agreements for the purposes of efficient portfolio management in accordance with the provisions of the Central Bank UCITS Regulations. The sub-funds did not enter into such agreements during the financial period ended 30 June 2021 and the financial year ended 31 December 2020.

**8. Taxation**

Under current law and practice the Company qualifies as an investment undertaking as defined in Section 739B of the Taxes Consolidation Act, 1997, as amended. On this basis, it is generally not chargeable to Irish tax on its income or gains.

However, Irish tax can arise on the happening of a “chargeable event” in the Company. A chargeable event includes any payments of distributions to shareholders, any encashment, repurchase, redemption, cancellation or transfer of shares and any deemed disposal of shares as described below for Irish tax purposes arising as a result of holding shares in the Company for a period of eight years or more. Where a chargeable event occurs, the Company is required to account for the Irish tax thereon.

No Irish tax will arise on the Company in respect of chargeable events where:

- a) certain exempted Irish resident investors who have provided the Company with the necessary signed statutory declarations; or
- b) any transactions in relation to shares held in a recognised clearing system as designated by order of the Revenue Commissioners of Ireland; or
- c) an exchange of shares representing one Sub-Fund for another Sub-Fund of the Company; or
- d) an exchange of shares arising on a qualifying amalgamation or reconstruction of the Company with another company; or
- e) certain exchanges of shares between spouses and former spouses.

In the absence of an appropriate declaration, the Company will be liable to Irish tax on the occurrence of a chargeable event. There were no chargeable events during the financial year under review. Dividends, interest and capital gains (if any) received on investments made by the Company may be subject to withholding taxes imposed by the country of origin and such taxes may not be recoverable by the Company or its shareholders.

**9. Expenses**

**Total Fee**

The Total Fee, a percentage of the Net Asset Value of the relevant class of shares, is payable by the Company out of the sub-funds’ assets to the Manager.

The Total Fee incurred by the Company during the financial periods ended 30 June 2021 and 30 June 2020 are detailed below.

Mr. Gijsbert Koning is a director of VanEck Asset Management BV. Mr. Adrian Waters and Ms. Mary Canning are entitled to receive a directors' fee of €20,000 per annum as payment for their services to the Company. Mr. Jon Lukomnik is entitled to receive a directors' fee of €7,500 per annum as payment for his services to the Company.

As outlined on page 3 of this report, Van Eck Associates Corporation acts as Investment Managers to certain funds of the Company pursuant to an investment management agreement between the Manager and the Investment Manager. VanEck Asset Management B.V. (the "Manager") acts as Manager and Distributor. The Manager is a 99% owned subsidiary of Van Eck Associates Corporation. Management Fees earned by the Manager are disclosed in the Condensed Statement of Comprehensive Income in Total fee and amounts owed in at the financial period end are disclosed in the Condensed Statement of Financial Position in the Total fee payable.

VanEck Switzerland AG and VanEck (Europe) GmbH are related parties, by virtue of the fact that they have a distribution agreement with the Manager and have the same ultimate parent group, Van Eck Associate Corporation, which held 914,750 (31 December 2020: 890,750) shares in the Company.

MV Index Solutions, the index provider of the MVIS Global Junior Gold Miners Index, which the VanEck Vectors™ Junior Gold Miners UCITS ETF seeks to track and the MVIS Global Video Gaming and eSports Index which the VanEck Vectors™ Video Gaming and eSports UCITS ETF seeks to track, is a wholly owned subsidiary of Van Eck Associates Corporation. The index licensing fees related to the VanEck Vectors™ Global Junior Gold Miners Index and the VanEck Vectors™ Video Gaming and eSports UCITS ETF are borne by the Manager.

A Director (Gijsbert Koning) held 4,690 shares at the beginning of the period, purchasing 5,135 shares, holding 9,825 shares with a value of USD338,158 as at 30 June 2021, and all transactions with that Director during the period are on normal commercial terms. An entity (Angkor Holding B.V.) controlled by the Director (Gijsbert Koning) held 7,994 shares at the beginning of the period, holding 6,713 shares with a value of USD347,017 as at 30 June 2021, and all transactions with that entity during the period are on normal commercial terms.

Two record holders of shares own 58.62% of the Company on behalf of Nominee accounts.

### Connected Persons Transactions

Regulation 43 of the Central Bank UCITS Regulations "Restrictions of transactions with connected persons" states that "A responsible person shall ensure that any transaction between a UCITS and a connected person is conducted a) at arm's length; and b) in the best interest of the unitholders of the UCITS".

As required under Central Bank UCITS Regulation 78.4, the Directors, as responsible persons are satisfied that there are arrangements in place, evidenced by written procedures, to ensure that the obligations that are prescribed by Regulation 41(1) are applied to all transactions with a connected person; and all transactions with a connected persons that were entered into during the financial period to which the report relates complied with the obligations that are prescribed by Regulation 41(1).

### 11. Contingent Liabilities and Commitments

There were no significant liabilities or commitments as at financial period ended 30 June 2021 and financial year ended 31 December 2020.

The Investment Manager did not enter into any directed brokerage services on behalf of the Sub-Funds during the period ended 30 June 2021 and year ended 31 December 2020.

### 12. Segregation of Liability

Under the provisions of the Companies Act 2014, the Directors maintain for each sub-fund a separate portfolio of assets. As between shareholders, each portfolio of assets is invested for the exclusive benefit of the relevant sub-fund. The shareholders are only entitled to the assets and profits of that sub-fund in which they participate. The Company is considered one single legal entity. With regard to third parties, in particular towards the Company's creditors, the Company is responsible for all liabilities incurred by a sub-fund exclusively based on the assets of this relevant sub-fund. Among the shareholders, the liabilities of each sub-fund shall only be incurred to the sub-fund.

**12. Segregation of Liability (continued)**

While the provisions of the Companies Act provide for segregated liability between sub-funds, these provisions have yet to be tested in foreign courts, in particular, in satisfying local creditors' claims.

Accordingly, it is not free from doubt that the assets of a sub-fund of the Company may not be exposed to the liabilities of other sub-funds of the Company.
