What is this Product?

The Product is a passively managed UCITS-ETF of VanEck ETFs N.V., an umbrella fund structure comprising different sub-funds. Type:

The VanEck Morningstar Developed Markets Dividend Leaders UCITS ETF is an exchange traded fund (ETF) which seeks to follow Objective:

the Morningstar® Developed Markets Large Cap Dividend Leaders Screened Select Index™ (gross total return index) as closely as possible.

The reference index measures the performance of high-dividend shares in developed countries worldwide. The Product is passively managed and invests in the underlying (physical) securities that make up the index and does not lend the underlying securities out to third parties. The Index applies ESG screening to its methodology, as described in the sustainability section of the ETF

The Morningstar® Developed Markets Large Cap Dividend Leaders Screened Select Index™ consists of 100 shares from a worldwide universe that satisfy criteria in relation to dividend policy, size and liquidity. The index uses a weighting method based on the total available dividend. The total available dividend per share is calculated by multiplying the number of freely tradable shares by the dividend per share.

Income from the Product's investments is paid out as dividend. There is the possibility of dividend 4 times per year, but the height of the dividend to be paid out must also be considered. It may be the case that the income from the dividend is relatively low in a particular quarter, which means that from a cost perspective, it makes more sense to keep the income in the Product until the next payment opportunity.

The Investment Manager will regularly monitor the Product's tracking accuracy. The annualised tracking error envisaged is not anticipated to exceed 0.5% under normal market conditions.

What happens if VanEck Asset Management B.V. is unable to pay out?
