What is this Product?

Type: The Product is a passively managed UCITS ETF of VanEck UCITS ETFs plc, an umbrella fund structure comprising different sub-funds. Under Irish Iaw, VanEck UCITS ETFs plc has segregated liability between its sub-funds. VanEck UCITS ETFs plc does currently not offer an exchange of shares for shares of another sub-fund. The shares are admitted for trading on various stock exchanges and can be traded on the secondary market. The price of the shares offered on the secondary market may deviate from the net asset value of the shares.

Term: No fixed term. We are entitled to terminate the management of the Product by giving at least one month notice to investors as published at least on our website.

Objective: The Product's investment objective is to replicate, before fees and expenses, the price and yield performance of the S&P Global Mining Reduced Coal Index (the "Index"). In order to seek to achieve its investment objective, the policy of the Product is to invest directly in the underlying equity securities of the Index, being the stock, American depositary receipts, global depository receipts, China B and China H shares issued by mining and metals companies whose predominant economic activity is the production of base metals and industrial such as iron ore. Further, the Product may hold the equity securities of companies whose predominant economic is in gold or other precious metal of mineral mining, however the Product does not hold physical gold or metal.

Where it is not practical or cost efficient for the Product to fully replicate the Index, the Investment Manager may utilise an optimized sampling methodology.

The Product may also or alternatively invest in financial derivative instruments which relate to the Index or constituents of the Index.

Further, the Product may use futures, swaps (for example Index swaps and equity swaps), currency forwards and non-deliverable forwards (a forward contract that does not require settlement on maturity), American depositary receipts, global depositary receipts or participation notes. The Product may invest up to 15% of its Net Asset Value directly in shares issued by companies listed on the Shanghai Stock Exchange or the

Shenzhen Stock Exchange. The Product may invest more than 20% of its Net Asset Value in emerging markets.

The Product may also invest in ancillary liquid assets and money market instruments that may include bank deposits, depositary receipts, certificates of deposit, commercial paper, floating rate notes and freely transferable promissory notes.

The Product may be leveraged through the use of financial derivative instruments; any such leverage would not be expected to be in excess of 100% of the Product's Net Asset Value.

The Product may not invest more than 10% of its Net Asset Value in open-ended collective investment schemes.

The Product may borrow money in an amount up to 10% of the market value of its net assets at any time for the account of any Fund and the Custodian may charge the assets of the Product as security for any such borrowing, provided that such borrowing is only for temporary purposes. The Product invests in the underlying (physical) securities that make up the Index and does not take part in securities lending.

Furthermore, the Product may not invest less than 51% of its Net Asset Value in equity securities which constitute "equity participation" within the meaning of section 2, Article 8 of the German Investment Tax Act.

The Product, using a "passive" or indexing investment approach, attempts to approximate the investment performance of the Index by investing in a portfolio of securities that generally replicates the Index. The Investment Manager will regularly monitor the Product's tracking accuracy. The annualised tracking error envisaged is not anticipated to exceed 0.6% under normal market conditions.

Dealing Frequency: You may purchase and redeem shares in this Product on a daily basis and in accordance with the relevant notice period.

Product's base currency: U.S. Dollar

Distribution policy: Income accumulated

The Depositary of VanEck UCITS ETFs plc is State Street Custodial Services (Ireland) Limited.

Recommended holding period: 5 years
