This person must have passion for investments, an aptitude for utilizing systems to analyze data, and a demonstrated ability to communicate complex concepts simply. This role requires attention to detail, great communication skills, the ability to manage many competing tasks and strong interpersonal skills.

Essential Duties and Responsibilities:

- Assists in the development, production, and updating of marketing materials (e.g. presentations, sales ideas, emails, press releases, etc.)
- Research competitors and analyze comparative performance, characteristics, and market trends to aid product development or marketing initiatives
- Management of key business reports and regulatory updates including market trends reports, board materials, and prospectus/annual report updates
- Participate in product development initiatives with expeditious analysis of new fund ideas as assigned
- Respond to product inquiries from Sales, including supporting RFP and DDQ requests with data as requested
- Other duties or special projects may be assigned as needed
