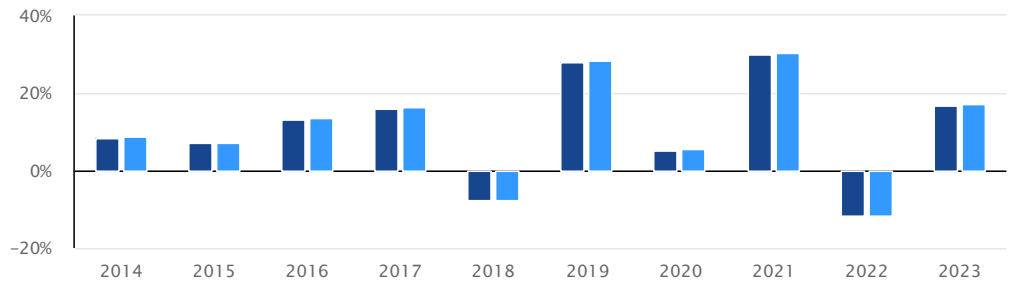
Fund Description
