## VANECK ANNOUNCES REVISED NET ASSET VALUE INFORMATION FOR VANECK RUSSIA ETF

NEW YORK (March 2, 2022) — VanEck announces the net asset value (NAV) per share of the <u>VanEck Russia ETF</u> (Cboe: RSX) was restated as shown below:

This value differs from the previously disclosed NAV. The NAV adjustment is a result of an error in calculating the NAV for RSX.
